Biometric Facial Recognition Proposal

In response to a request by the Clark County Sheriff's Office, EIS is pleased to present this proposal to add biometric facial recognition capabilities to the existing Jail Management System. This addition will complement the existing fingerprint Identification system currently deployed and will provide additional biometric validation capabilities.

This system can be immediately productive by using the existing library of inmate photos and can be expanded at a later date to include field identification capabilities.

The proposal includes all required software and implementation services from EIS. We anticipate that the core system will operate on existing servers currently running the JMS system and no special hardware will be required.

Project Goals

1. Enhance the existing EIS Biometric platform utilized by the Clark County Sheriff's Office with the facial recognition identification sub-system.
2. Provide subject identification during intake by searching previous booking records based on an associated facial image.
3. Provide rapid inmate validation during release.

Software Description

The JMS Biometric System is intended to quickly identify subjects as part of the booking intake process, general search, and release from the facility. This helps ensure that inmates are booked under the correct name and can speed bookings by facilitating prior record retrieval. During release officers can verify identity to help ensure that the appropriate inmate is being processed. Facial recognition can provide a rapid, non-intrusive identification capability that can quickly compare images based on specific biometric facial characteristics.

Appendix B –Facial Recognition Best Practices

Face recognition accuracy heavily depends on the quality of a face image, and the ability of the algorithm to locate salient features on the subject's face. Image quality (e.g. resolution, lighting, etc.) during enrollment is important, as variations in quality will have impact on the quality of the face registration template.

General Guidelines

- Native image resolution should be at minimum 32 pixels is the recommended minimal distance between eyes for a face on image or video stream to perform face template extraction reliably. 64 pixels or more recommended for better face recognition results. These standards are enforced by images acquired through the EIS advanced imaging capture solution, however may be variable based on images acquired through other sources.
- Items of clothing or other elements that impact the eye regions of the face (Glasses, hair, etc.) can impact the quality of the resulting image templates. Glasses should be removed during primary facial enrollment.
- Additional enrollments may be needed when facial hair style changes, especially when beard or mustache is grown or shaved off.

Face posture

The face recognition engine supports an optimal facial position criterion, and certain tolerances to face posture:

- head roll (tilt) – ± 30 degrees is the recommended setting for most near-frontal face images.
- head pitch (nod) – ± 15 degrees from frontal position.
- head yaw (bobble) – ± 15 degrees from frontal position for most near-frontal face images.
