WHEREAS Detective Joel D. Rivas (#731) has this day made complaint under oath to the undersigned, one of the judges of the above entitled court in and for the said county, and whereas the undersigned has made a finding of probable cause that crimes have been committed in Pierce County, Washington, to wit:

That on or about 23 December, 2015 in Pierce County, Washington, a crime or crimes were committed by the act, procurement or omission of another—to wit: **Robbery in the First Degree (9A.56.200)**, and that the following evidence and cooperation are important to the investigation and prosecution of the aforementioned offense(s) relating to FBI case number 91A-SE-6792373 and Tacoma Police Departments case # 15-35700738.

Washington State Department of Licensing (DOL) facial recognition systems (FRS) query to identify any images and related personal identifying information associated with any Washington State driver licenses, instruction permits or identification cards that are similar to subject photos submitted to the Washington State Department of Licensing. Such query will be in accordance with RCW 46.20.037.

The above listed items are material to the investigation or prosecution of the above described crime(s) and that said Detective Joel D. Rivas (#731) verily believes said evidence is likely concealed in or about a particular person, place or thing, to-wit:

The computer databases and archives of the Washington State Department of Licensing. The Facial Recognition System office (FRS) is located at 1125 Washington Street SE, in Olympia, WA (98507)in the Highways and Licenses Building.

Washington State Patrol Detective Joel D. Rivas (#731) request that the material response to this warrant be made vie e-mail to his police e-mail address: <u>joel.rivas@wsp.wa.gov</u>, unless a digital transmission is not practicable.

If unable to respond via e-mail, it would then be requested that the material response be sent via priority delivery to Detective Joel D. Rivas, Washington State Patrol, 1145 Broadway Suite #500, Tacoma WA 98402.

If clarification of requested material is necessary, Detective Rivas can be reached by e-mail or telephone at <u>joel.rivas@wsp.wa.gov</u> and (360) 507-2585, respectively. Response to this shall be within a reasonable period of time to process the order, not to exceed 20 days.

It is further ordered that for at least 180 days, the respondent to this warrant or any associated persons, refrain from disclosing the existence of this warrant either directly or indirectly, to any person who may in-turn disclose this warrant's existence to the subject of the warrant. Such a disclosure could facilitate the destruction of evidence, notification of confederates, or initiation of flight from prosecution.

A copy of this warrant shall be served upon the person of persons found in said place; if no person is found, a copy of this warrant shall be posted conspicuously upon a place in or on said location. A copy of this warrant and resulting inventory shall be returned to the undersigned judge or his agent as soon as practicable after execution.
