


## DECLARATION OF VANESSA ARNO

1. My name is Vanessa Arno and I am a Staff Attorney at the Northwest Immigrant Rights Project.
2. On August 26, 2014, I observed a bond hearing at the Tacoma Immigration Court, which is located at 1623 East J Street, Suite 3, Tacoma, Washington. The name of the respondent was Maria Sandra Rivera, A #206-717-040. The Immigration Judge who presided over the hearing was John C. Odell, and the Department of Homeland Security was represented by Joseph Silvio. Ms. Rivera was represented by Elizabeth Benki.
3. At the beginning of the hearing, Ms. Benki asked Judge Odell if he had received her argument in support of granting release for Ms. Rivera under conditional parole. Judge Odell responded that he had, and he stated that the Court had no jurisdiction to grant conditional parole to Ms. Rivera.

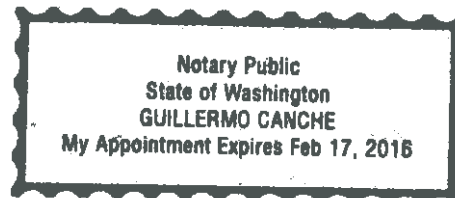
