The remediation efforts for these three stairways have been completed, and stairways are now enclosed in the same manner as the 20 21 stairway in wing A, which this Court stated "does not present an unreasonable risk of 22 irreparable harm." Dkt. #263, at 4. Attached is a declaration from Susan Copeland, 23 Residential Services Manager at Maple Lane, detailing the remediation efforts. Declaration of Susan Copeland ¶¶ 2-4. The Department respectfully requests that the temporary restraining 24

order restricting use of wings B, C, and D at the Maple Lane Competency Restoration Program

be immediately lifted.
