

How to Find School Discipline Data: Numbers of Suspensions and Expulsions

Washington's Office of Superintendent of Public Instruction publishes data on student discipline in every school district in the state. If you have the Microsoft Excel program, you can download the data and review it. To find the data:

Step 1: Go to <http://www.k12.wa.us/DataAdmin/PerformanceIndicators/DataAnalytics.aspx#discipline>

Step 2: Scroll down to number 13 in the table, and click on 13.Discipline

6. Dual Credit Programs	The percentage of students enrolled in dual credit programs and the percentage of students who earned dual credits and certificates (e.g., AP, IB, Running Start, Tech Prep)	Dual Credit Programs State Report Card
7. SAT and ACT	The percentage of students who took the SAT and ACT, and the average SAT and ACT scores earned	
8. Postsecondary Enrollment and Remediation	The percentage of high school graduates who were academically prepared and attended postsecondary education institutions within one year of graduating high school	High School Feedback Reports
9. Financial Aid for College	The percentage of students who accessed financial aid for college	Financial Aid Overview
10. Postsecondary Persistence	Percentage of students who persisted in postsecondary programs and completed certificates and degrees	
11. Graduation Rates	Four-year and five-year graduation rates	Graduation and Dropout Statistics Graduation: A Team Effort
12. 9th Grade Course Failure	ELA, math, and science course failure rates in 9th grade	
13. Discipline	Suspensions and expulsions	Discipline Annual Discipline
14. Attendance	Attendance, especially chronic absenteeism	Attendance

Step 3: Download the data file entitled “Discipline Rates (School Years 2012-13, 2013-14, 2014-15)”

13. Discipline

What do these discipline data show?

- How many students are suspended or expelled
- Who is suspended or expelled (by race, sex, program, etc.)

What do the discipline behavior data show?

- How many times students are suspended or expelled
- How long are they removed
- For which behaviors

Step 5: Review the data for the following questions:

- a) What is the school district's overall rate of suspension and expulsion?
- b) Is the school district's overall rate of suspension higher or lower than the state average?
- c) Does the school district disproportionately suspend or expel students of any racial or ethnic group?
- d) Does the school district disproportionately suspend or expel students who receive special education services or accommodations under section 504?
- e) Does the school district disproportionately suspend or expel students in any other sub-groups (i.e, students who are low income, students who are English Language learners).
- f) How many individual students are suspended or expelled?
- g) What is the average number of suspensions and expulsions per student? Are students likely to be suspended more than once?
