Claire Wilson is the current President of the Federal Way School District Board of Education, Position 2. She was re-elected as a School Board Director, Position 2 in the 2015 General Election. Her current position expires in December 2019. She originally took office on December 13, 2011.

What is their professional background?

Claire Wilson is a career education professional. She spent three decades teaching preK - 12 at risk and non-traditional students. Claire spent 25 years working for the Puget Sound Educational Service District (PSESD), specializing in early education and family involvement. Prior to working for the PSESD, Claire taught pregnant and parenting teens at Mt. Tahoma High School and worked as a senior grants and contracts manager for a City of Seattle teen parenting program.

What community activities do they engage in?

She currently is a member of the Expanded Learning Opportunities Council (ELOC) as the Washington State School Directors Association (WSSDA) Representative. She is a Board Member of the Sidekick Collective, a private non-profit supporting ordinary youth doing extraordinary things through seed money and mentoring. She is also an Advisory Board Member to the Washington State Family and Community Trust Organization. Claire has extensive volunteer experience in South King County including PTA, Citizens for Federal Way Schools, the Building Better Futures Board in Kent, the Advisory Board of the Washington Family Engagement Trust, and the Board of Directors for The Sidekick Collective.

Pellicciotti is dedicated to public service in South King County. His priority issues include working families; reforming government, including getting dark money out of politics; improving public safety in King County; stopping human trafficking; healthcare; tax reform; job growth and transportation improvements; education; and equal justice.

Has the candidate expressed views (positive or negative) on any of the following ACLU issues?

Pellicciotti is vice-chair of the standing House Public Safety Committee. This Committee is relevant to ACLU's issues of concern as it considers policy relating to law enforcement agencies, crime prevention, criminal penalties and sentencing, impaired driving, registration and civil commitment of sex offenders, adult correctional programs and institutions, and state and local government preparedness to respond to public emergencies.

Pellicciotti is a former Chair of the Equal Justice Coalition (http://ejc.org). The mission of this group is to ensure that people are treated equally and fairly before the law by educating policymakers and the public about the importance of civil legal aid in our communities and advocating for sufficient public funding for civil legal aid on behalf of low-income people in Washington State.

Pellicciotti was a sponsor of a successful bill (effective 6/7/2018) concerning civil legal aid. This bill provides funds for legal aid to support important basic rights of low income persons in Washington State including healthcare, disability rights and education (http://lawfilesext.leg.wa.gov/biennium/2017-18/Pdf/Bills/House%20Passed%20Legislature/2308-S.PL.pdf#page=1).

Mike Pellicciotti was graded "A" by NARAL Pro-Choice Washington. According to NARAL, this grade means that the candidate is a Champion devoting tremendous time and energy to protecting and expanding choice through bills and policies. They proactively and publicly utilize their platform to speak up and push to expand reproductive access (https://prochoicewashington.org/laws-policy/legislator-scorecard/).

Pellicciotti was elected to his current position in the Washington House of Representatives in November, 2016. He will advance from the August 7, 2018 primary to the November 2018 general election where he will face Republican Linda Kochmar. Pellicciotti received 58% of the votes to Kochmar's 42%. These two candidates ran unopposed.

In 2017, Pellicciotti was vice-chair of the House Public Safety Committee.

In 2017, Pellicciotti was a member of the State Government, Elections & Information Technology and Transportation Committees.

In 2005, Mike began a career in public service when the late-King County Prosecuting Attorney Norm Maleng first appointed Mike to serve as a Deputy Prosecuting Attorney. Mike led cases against sex trafficking and domestic violence in South King County. As Assistant Attorney General, Mike combated elder abuse and corporate healthcare fraud, returning \$30 million to taxpayers.
