I will always vote pro-choice and will work to protect access to safe, legal abortions, including supporting public funding to offer that and other family planning services. Unfortunately many women are unaware of all their options, so in the State Senate I will support requiring hospitals and health centers to provide patients with medically accurate and comprehensive health information, as well as referrals, regardless of religious affiliation.

As a single mom of three, I provide a unique perspective about the experience of women and the challenges of being treated equally in the workplace while caring for their families. We must strengthen family leave and equal pay. While Washington has made some great strides to address unfair pay, there are still gaps in our laws that allow the pay gap to worsen that must be addressed, including banning employers from requiring applicants to disclose their salary history before getting a job offer."

More recently, she has led efforts to implement the federal Affordable Care Act at the state level. Largely because of her work, Washington's online health care marketplace, Washington Healthplanfinder, is a model for the rest of the country – helping thousands of Washingtonians access affordable coverage.

Some of her more recent legislative accomplishments have been honored by groups like the American Medical Association, Planned Parenthood, the American College of Emergency Physicians, the Washington State Medical Association, and Sound Mental Health.
