Greetings All,

Attached are the most recent lists for your use. As usual, please let me know if you find updated or new information that is not included here. A reminder that the **orange** highlighted website on the Useful Websites tab of the Contacts list, can route you to contact information for businesses for which I do not have an entry on the list.

There are still a number of posts going out that are

- Asking someone from a specific agency to call them,
- Stating the need of a contact for a business/bank that is already available in the monthly lists, and/or
- A follow up Thank You/Got It post that doesn't include the information sought.

As a reminder, those posts are subject to having posting privileges suspended for a time. In the six month period between June 11 and December 31, 2015 there were 33 suspensions.... An average of 5 per month. From January 1 – today, 2016, there have been 14 suspensions, an average of 5.6 per month. We are moving in the wrong direction!!!

Thank you in advance for trying to reverse that trend!

Hope you all had nice holidays and have been keeping warm during this COLD period.

Attached are the latest lists. As always, please remember to CHECK THE LISTS PRIOR to sending out a request for information, and, to INCLUDE THE INFORMATION RECEIVED in your Thank You post. That way I can update the lists without having to chase you down for the information. Also, if you need to speak with an investigator from a specific agency, CALL A CONTACT LISTED FOR THAT AGENCY instead of sending out a post that goes to the other 300 +/- agencies with subscribers.

For the newer subscribers to the list, take the time to familiarize yourselves with all the tabs in the worksheets. There is a LOT of information listed. Also remember to use the CTL + Find command if you are looking for something and it isn't where you think it should be. Most State Agencies are listed with a WA in front of them, so you would find DSHS or DOL in the "W" section, not the "D" section. Likewise, most Federal agencies are listed with a US in front of them, so you won't find the Army in the "A" section or the IRS and Insurance Commission in the "I" section but you will find them in the "U" section. Also, if you can't find something under one term, try a synonym. Such as if you are looking for a Handwriting analyst and can't find it under Handwriting, try looking for a Document Examiner. I have tried to put things in logical order, but there are many instances of different terminology and I couldn't cover all bases or the list would be too large to make it through the servers.

Also, as always, please let me know if there are any changes in your or your agencies' contact information and if you develop a contact for a business that is not included on the lists that you think would be beneficial for the other subscribers to have.

Thanks much.

May 2016 bring about a more positive relationship between us and the public. I don't have much hope for the way the media portrays us, but we can hope for improvement there too.

CODE 4(A) to access a personal info search database, IRB Search, which is similar to TLO or Accurant. The suspect made it appear that one **CODE 4(A)**, who is black, had used the identity of a second **CODE 4(A)**, who is white and has a (now expired) Washington private investigator license in order to apply for access to the website. The suspect went so far as to provide a forged PI license, documents and create an investigation business website. The driver's license below is also counterfeit. A facial recognition search did not find any matches. I'm not sure if he is local or not, but is guessing he may be.
